## Big wins for Teamsters in Election Day results

rom coast-to-coast, a historic number of hardworking Americans showed up and had their voices heard at the polls this November. And taken together, they made it clear that the status quo that has favored the powerful in government is no longer acceptable.

Whether it was the defeat of virulent anti-union GOP governors like Wisconsin's Scott Walker and Illinois' Bruce Rauner; the onslaught of inspiring victories by women candidates such as Gretchen Whitmer for governor of Michigan or Jacky Rosen for U.S. Senate in Nevada; or the retaking of the House of Representatives by Democrats, Americans have sent a message that lawmakers haven't been standing up for them. That has to change.

Not only did Teamsterbacked candidates prevail at the top of the ticket, but it trickled down to the statehouse level as well. Democrats flipped the Colorado Senate, Maine Senate, Minnesota House, New Hampshire House, New Hampshire Senate and New York Senate on November 6 and now have full control of government in Colorado, Illinois, Maine, Nevada, New Mexico and New York because of it.

Our own members helped lead the way, with key victories by Teamsters like retired BLET Division 391 President Jeff Kurtz in the Iowa House: Susan Martinez in the Nevada House: and David Delloso and Steve Malagari in the Pennsylvania House, among others.

Too many elected officials have chosen to attack unions in recent years. But that's going to stop right now. Workers first proved in Missouri last August that terrible laws like so-called right-to-work can't be shoved through by elected officials against the will of the people. The vote on November 6 reinforced that position.

Hundreds of Teamsters mobilized across the country to get these new union-endorsed lawmakers elected. Now, the Teamsters stand ready to help chart a new course for this nation, one that prioritizes workers by advocating for better pay, respect on the job and a secure retirement. Let's get to work!

## Election Day victories and challenges

ow that one of the most consequential midterm elections of our lifetime is behind us, we have some things to celebrate and some significant challenges ahead.

In California, an attempt to rescind the state gasoline tax was overwhelmingly rejected by voters, thereby protecting \$54 billion in additional infrastructure investment. including the state's highspeed rail project. The HSR project already has billions of dollars invested in two dozen construction sites in the state. employing over 2,000 workers in high-wage jobs, and reducing unemployment in California's Central Valley below double digits for the first time in decades.

We'll have to see how much political muscle Governorelect Gavin Newsom puts behind the project. Outgoing Governor Jerry Brown was a prime supporter of it. During his victory speech, Newsom "committed" to completing the first phase of the highspeed rail project from Silicon Valley to the Central Valley. And we'll have to see what measure of federal funds Nancy Pelosi, the anticipated new Speaker of the House, is able to secure for it. In the meantime, the project continues to move forward with existing revenue sources.

In Colorado, voters rejected two infrastructure initiatives: Propositions 109 and 110 by margins of 60 to 40 percent. The law requires Colorado's secretary of state to propose another transportation measure for voters in 2019.

In Florida, voters struck down Amendment 11, a constitutional provision requiring the state to develop high-speed rail. The so-called "requirement" to develop high-speed rail is a hold-over from a voter initiative in 2000.

In other state and local elec-

tions, transportation initiatives were voted on. The absence of leadership at the federal level has caused transportation funding issues to devolve to the states and local jurisdictions. Given that the House has changed hands, we hope the Federal government will once again assume its leadership role in funding our growing infrastructure needs.

# United, Moving Forward

President Pierce reelected by acclamation; VPs Davis and Gore announce retirements at Fourth National Convention

he Fourth National Convention of the Brotherhood of Locomotive Engineers and Trainmen (BLET) convened in Las Vegas from October 1-4, 2018, with more than 400 delegates in session representing over 57,000 locomotive engineers, trainmen and non-operating craft members on national freight and passenger rail systems across the United States.

The BLET's national conventions are held quadrennially, or once every four years. The delegates completed a great deal of hard work in a short period of time, which included analyzing and voting on changes to the Brotherhood's Bylaws and the nomination of National Division officers. Several invited dignitaries addressed the delegates as part of the convention proceedings, and delegates also heard reports from various

BLET officers.

In terms of officer elections, Dennis R. Pierce was reelected by acclamation to his third full term as BLET National President on October 3, 2018. Additionally, all Advisory Board members were elected without opposition.

"I am humbled. I am honored," President Pierce said. "It's a privilege to serve you. This is a great Union, and we can do great things as long as we stick together. So thank you again."

It was also announced that National Vice President Gil Gore and National Vice President Cole Davis would be retiring. Both men made emotional farewell speeches to the delegates.

In addition to President Pierce, the following officers of the Advisory Board were elected by acclamation to four-year terms, and they will be sworn in to office on January 1, 2019:

eral Chairman of the Norfolk Southern-Southern Lines General Committee of Adjustment (GCA) since 2012. Brother Wallace will fill the vacancy created by the retirement of Vice President Davis.

New to the Advisory Board is Vice President Alan Holdcraft, who currently serves as General Chairman of the BNSF (former ATSF) GCA. Brother Holdcraft will fill the vacancy created by the retirement of Vice President Gore.

Also new to the Advisory Board is Trustee Richard E. (Dick) Crow, General Chairman of the Union Pacific-Northern Region GCA. Brother Crow fills the vacancy created by Trustee Wallace's elevation to the office of National Vice President.

Twelve alternate officer positions also

were filled by acclamation. They are as follows: David P. Estes, Alternate National Secretary-Treasurer; Vincent G. Verna, 1st Alternate Vice President and National Legislative Representative; Paul S. Piekarski, 2nd Alternate Vice President and National Legislative Representative; William P. Lyons, 1st Alternate Vice President; Richard E. Crow, 2nd Alternate Vice President; L. Randy Fannon, 3rd Alternate Vice President; Peter Semenek, 4th Alternate Vice President: Patrick Driscoll, 5th Alternate Vice President; Garrison Best, 6th Alternate Vice President: Brian Carr, 7th Alternate Vice President: A. Dan Cook III, 8th Alternate Vice President; and Jeff Thurman, 9th Alternate Vice President.

Throughout the week, delegates ana-

lyzed and voted on changes to the Brotherhood's Bylaws, and heard reports from numerous guest speakers. The list of speakers (in alphabetical order) included: Railroad Retirement Board Labor Member Walt Barrows: Ohio Senator Sherrod Brown: Nevada Senator Catherine Cortez Masto; Teamsters General Secretary-Treasurer Ken Hall; BLET Auxiliary National President Sereena Hogan; Teamsters General President James P. Hoffa; National Transportation Safety Board Member Jennifer Homendy; Massachusetts Congressman Joe Kennedy, III; Teamsters International Vice President & Rail Conference Director John Murphy; Ohio Congressman Tim Ryan; and Massachusetts Senator Elizabeth Warren.

## DELEGATES APPROVE BYLAWS CHANGES

elegates to the BLET's Fourth National Convention spent many hours in session debating and approving changes to the BLET's Bylaws. Among the many resolutions they adopted are two important changes to the BLET Bylaws. One change would allow the National President to reconfigure the BLET Short Line Department, which will allow the BLET to further its reach in organizing. A second Bylaws change would allow the BLET to potentially grow the union by expanding its ability to represent a more diverse workforce. For example, the BLET

has declined numerous requests for organizing campaigns made by unrepresented workers of railroad companies not subject to Surface Transportation Board jurisdiction — and, hence, not subject to the Railway Labor Act — as well as unrepresented workers for so-called "light rail" or transit systems. Delegates approved a proposal that will provide the BLET with the ability to organize and represent properties outside of our current structure. These Bylaws changes will become official once it has been confirmed that they do not conflict with the IBT Bylaws.

# Mark L. Wallace elected BLET National Vice President

ark L. Wallace was elected by acclamation to serve as National Vice President of the 57,000-member Brotherhood of Locomotive Engineers and Trainmen (BLET) at the union's Fourth National Convention in Las Vegas, Nevada, on October 3, 2018.

At the time of his election, Vice President Wallace was serving as a National Division Trustee and as General Chairman of the Norfolk Southern-Southern Lines General Committee of Adjustment (GCA), which represents 43 Divisions with over 3,000 members. He was elected by acclamation to the General Chairman's position on May 8, 2012 and again in 2016. He was elected by acclamation to the office of National Division Trustee at the BLET's Third National Convention in Las Vegas on October 1, 2014.

Prior to his election to General Chairman, Brother Wallace served as the full time 2nd Vice General Chairman. He is currently an active member of BLET Division 267 (Asheville, N.C.), having joined the Brotherhood on February 1, 1997.

He began his railroad career as a carman with Norfolk Southern in 1993 transferring to the craft of conductor in 1996. In 1998, Brother Wallace successfully completed his locomotive engineer training and attained seniority as a locomotive engineer.

Brother Wallace began his service to the union immediately after joining Division 267. He served as an appointed Local Chairman to trainmen/conductors and Vice Local Chairman before becoming Local Chairman in 2000. He has served as delegate to the BLET National Conventions in 2001, 2006, 2010 and 2014 having served on the Credentials Committee in 2001. Brother Wallace was also elected as 9th Alternate Vice President at the 2001 convention and 1st Alternate Vice President in 2014.. He served as the Southeast Caucus Chair-

man in 2006 and is currently the Chairman of the Southeastern General Chairman's Association.

Prior to his railroad career, Brother Wallace attended the University of North Carolina at Asheville where he earned his Bachelor of Arts Degree in Political Science. He follows in the footsteps of his father, Ray C. Wallace, who was a locomotive engineer, Local Chairman and General Chairman from 1986-2008. His mother Janie was very active in the Grand International Auxiliary (GIA), serving as a national officer, and also served as Executive Secretary of the NS-Southern Lines GCA for many years.

Brother Wallace has participated in every facet of membership representation at many levels, beginning at the grassroots level and working his way up through the local level to the General Committee and the National Division. He has served as Vice Local Chairman, Local Chairman, 4th Vice General Chairman, 3rd Vice General Chairman, 2nd Vice General Chairman, General Chairman, 9th Alternate Vice President, 1st Alternate Vice President and National Division Trustee.

As General Chairman, Brother Wallace has participated in many on-property negotiations with Norfolk Southern, including negotiations for the current wage package negotiated in 2015. He served on the National Wage Team in the round of bargaining that resulted in the current National Agreement. He was assigned as a member of the Rail Safety Advisory Committee (RSAC) Two Person Crew Working Group. He manages all day to day issues arising on his general committee as well as all on-property handling of time claims, discipline claims, and protective benefits. He also is the Administrator of the short term disability plan for all engineers on the Norfolk Southern property as well as serving as a fiduciary on the negotiated 401K plan.

Brother Wallace was born October 4, 1969. He and his wife, Rhonda, have a daughter, Morgan, and sons, Presley and Carson. They also have a grand-daughter, Paisley. In his free time, Brother Wallace enjoys spending time with his family, camping, and watching his boys play sports.

## J. Alan Holdcraft newest member of the BLET Advisory Board

Alan Holdcraft was elected by acclamation to the office of BLET National Vice President at the BLET's Fourth National Convention in Las Vegas, Nevada, on October 3, 2018. He currently serves the BLET as General Chairman of the Burlington Northern Santa Fe (former AT&SF) General Committee of Adjustment (BNSF-ATSF GCA), which represents nearly 3,150 members from 35 different BLET Divisions.

Vice President Holdcraft began his railroad career on June 1, 1977, when he hired out as a trainman with the Santa Fe Railroad in Galveston, Texas. He began engineer training in November of 1977 and earned promotion to locomotive engineer on May 6, 1978. He has held continuous membership in BLET Division 776 (Galveston, Tex-

as) since initiating into the Brotherhood on February 1, 1980.

Vice President Holdcraft is a dedicated union leader who has served the Brotherhood in numerous elected offices over the years. From 2002-2008, he served as Local Chairman of Division 776. From 2008-2011, he served as Vice General Chairman of the BLET's BNSF-ATSF GCA. He was elected BNSF-ATSF General Chairman in 2012, and was reelected by acclamation in 2014 and 2018.

ichard E. "Dick" Crow was elected by acclamation to serve as a BLET National Division Trustee at the union's Fourth National Convention in Las Vegas on October 3, 2018.

Brother Crow is a Union Pacific locomotive engineer and a member of BLET Division 404 (Chicago, Illinois). Brother Crow currently serves as General Chairman of the Union Pacific-Northern Region General Committee of Adjustment (UP-NR GCA), which represents approximately 1,200 active locomotive engineers and trainmen who work for the Union Pacific Railroad and Metra commuter lines.

Brother Crow began his railroad career in 1996 when he hired out as a trainman with the Union Pacific in Chicago, earning promotion to locomotive engineer in June of 1999. He has

# 'United, Moving Forward:' President Pierce addresses delegates


LET National President Dennis R. Pierce delivered the Report of the National President at the BLET's Fourth National Convention on October 1. With the theme of "United, Moving Forward," President Pierce's report focused on to two general areas: the major accomplishments of the Brotherhood over the past four years since the Third National Convention concluded in 2014; and what challenges lie ahead for the organization.

President Pierce told the delegates: "This week you are the National Division. This week you will set the course for this great Brotherhood as we enter a time that is more perilous than any of us have seen or can even imagine in our lifetimes."

During that past four years, the National Division negotiated a new national contract, which protected work rules, preserved health and welfare benefits, and provided real wage increases. The National Division also assisted its General Committees of Adjustment with more than a dozen on-property agreements that have been ratified, including: Amtrak, Norfolk Southern, CSX, Long Island Rail Road, SEPTA, New Jersey Transit, and several short line railroads.

President Pierce also touched upon the BLET's legislative agenda, describing how the union has worked to fix problems associated with the Family and Medical Leave Act (FMLA) and has lobbied for a national two-person crew bill. "Our National Legislative Office continues to be the best in the business, and they do a great job given the current climate in Washington," he said.

President Pierce also discussed legislative victories on the state level, including passage of a two-person crew bill in California, a new train crew transportation safety law in Washington state, and victories in overturning harmful "right-towork" laws in Missouri. He also acknowl-

In terms of two-person train crews, the BLET secured a major legal victory in 2015 when the Sixth Circuit Court of Appeals ruled that our 2013 strike at the Wheeling & Lake Erie involved a major dispute, and then convincing the Supreme Court not to disturb that ruling. The struggle continues, however, as our W&LE Brothers and Sisters continue to oppose management on the issue of one-person train crews. President Pierce also discussed the Brotherhood's current legal battle to stop the Kansas City Southern from allowing Mexican train crews to take the jobs of American workers in Laredo, Texas.

President Pierce also emphasized the many benefits BLET members enjoy by belonging to a union. Those benefits include: strong Railroad Retirement and an occupational disability pension; health care benefits; paid time off; high wages; seniority rights; the right to representation and an appeal process when facing discipline; and a whole range of work rules to protect locomotive engineers and trainmen while on the job.

"These advantages ... are not enjoyed by the 93.5 percent of private sector workers not represented by a union," he said. "And all of these are the things Corporate America and the one percent want to take back from BLET members and all union workers, so they can stick that money in their own pockets."

Looking ahead, the BLET and all of organized labor is facing unprecedented challenges as Corporate America has chipped away at worker-friendly laws over the past 40 years, culminating in the Supreme Court's Janus decision this summer.

"The Janus ruling is intended to drive unions into bankruptcy by forcing them to expend resources on people who pay nothing for their representation," he said.

Emphasizing that "elections have consequences," President Pierce advised BLET members to vote for union-friendly candidates in the upcoming November elections.

"Mark my words — unless average Americans rise up en masse to take back their federal government this fall — in order to protect and preserve their economic security — we will face some very difficult choices in the coming years. But I do have to share that we won't be in a situation that is completely foreign to our Brotherhood," he said.

In spite of these challenges, President Pierce concluded his presentation on an optimistic note.

"This Brotherhood didn't survive for 155 years by conducting itself like a bank, or an insurance company, or any other type of service business," he said. "The BLE survived — and thrived — because of its core ethic, which dates back to 1863: each member has a personal obligation to be informed, and the responsibility to act in concert with other members. In other words, we must be united, moving forward!"

President Pierce received a standing ovation following his presentation.



# Vice Presidents Gil Gore, Cole Davis deliver farewell speeches

LET National Vice President Gil Gore and National Vice President Cole Davis delivered emotional farewell speeches during the BLET's Fourth National Convention on October 3, 2018. Both men will retire effective December 31, 2018.

Gore's railroad career began on July 26, 1973, when he hired out as a fireman on the Texas and Pacific Railroad. He earned promotion to locomotive engineer in December of 1973. Brother Gore represented the membership in all facets of union work including arbitration regarding discipline, protection, and work rules. Gore joined BLET Division 193 in Gretna, La., on February 1, 1974, and is a Union Pacific locomotive engineer. The past 44 years of his life have been devoted to serving the Brotherhood and its members.

Vice President Gore served Division 193 as Local Chairman for 20 years from 1980 to 2000. He was elected Vice General Chairman of the Union Pacific-Southern Region GCA in 1986, an office held until 1998. In 2000, he was elected to the General Chairman's position on the UP-SR GCA, which he held until his elevation to Vice President in 2009.

He was elected to the position of Fourth-Alternate Vice President at the BLET's First Quadrennial Convention in Las Vegas, Nevada, in 2006. He eventually worked his way up to the firstalternate vice president position, and was promoted to the Advisory Board on December 17, 2009. He was elected by acclamation to serve as National Vice President at the BLET's Second National Convention in October of 2010, and was reelected by acclamation to another term of office at the BLET's Third


National Convention on October 1, 2014.

"As I sat in my room gathering my thoughts, it struck me that throughout my 38 years of union service, there has always been one common thread that connects us all," Brother Gore said. "That thread runs through me, runs through you, and all of the BLET mem-

bership around this great country. That thread has the tensile strength of titanium, yet is flexible enough to stretch to connect us all irrespective of our race, religion, gender, social status, economic standing or political beliefs. And despite sometimes the Herculean effort of others, both internal and external forces, to break it, this common thread has maintained resiliency and endured. The common thread that I am talking about you cannot see because it is not visible. It cannot be touched, because it has no physical form. It cannot be heard, because it has no audible voice. Yet we find evidence of it around us every day as it manifests itself to us all in many different ways: a simple display of kindness and compassion shown to a friend; an act of charity to help a person in need; a phone call to a Brother and Sister who has been involved in a serious accident to let them know that we care; a heartfelt thank you to someone who has provided us assistance. The common unbreakable thread that I am speaking about is the spirit of brotherhood that dwells in me, in you, and in all our members across the country.

"It is the same spirit of brotherhood that possessed 12 men to gather in Detroit, Michigan, on May 8th in 1863 to band together, risking their families' futures and fortunes to found the Brotherhood of the Footboard. Over the last 155 years that same spirit of brotherhood has been stretched paper thin as a result of the mistakes of flawed human beings, only to snap back into a strong titanium cable that connects us all. I'm here to tell you now, if we continue to nurture and grow this spirit of brotherhood, it will see us through the new political and judicial challenges that we face in the near future."

Vice President Gore thanked his wife, Denise, his recognized his son Jared and daughter-in-law Liz, daughter Emily and son-in-law Derek, and his grandchildren Eloise, Evelyn and Emmett Cade (known affectionately as "The Dude").

Vice President Davis has been a proud member of the Brotherhood for nearly 35 years, joining Division 86 on January 1, 1984. Throughout his career he has served as Vice Local Chairman, Local Chairman, Vice General Chairman, and General Chairman. Vice President Davis began his railroad career in 1968 when he hired out as summer help for the Norfolk & Western Railroad. In 1970, he hired out as a switchman for the N&W in Moberly, Mo. He transferred to road service as a brakeman two years later and then transferred to engine service in 1974.

He was elected by acclamation to his first term as National Vice President at the BLET's Second National Convention in 2010, and was reelected by acclamation to his second term at the Third National Convention in 2014. Prior to his election to the BLET Advisory Board,

Vice President Davis served as General Chairman of the Norfolk Southern (Northern Lines), Wheeling & Lake Erie and Chicago, Ft. Wayne & Eastern General Committee of Adjustment.

During his farewell address, Vice President Davis said he earned \$23 per day early in his career, but that his pay and benefits steady increased over the years thanks to the strong labor movement in the railroad industry. He also described poor cab conditions that existed when he first transferred into engine service, including high noise levels, poor braking systems, and lack of air conditioning. Those conditions improved drastically over time, thanks to the efforts of the BLET.

"In 1970, radios weren't standard equipment on the engines, and only a few of the crews had walkie-talkies, which they had to purchase themselves," he said. "All the cars had AB brakes which restricted train lengths to a mile in the summer months and no more than 60 cars. in cold weather. The automatic brake on the engine was a 6BL which didn't have a maintaining feature. The modern 26-L brake became standard in the late '70s, and we wouldn't see the dynamic brake introduced until the early '80s. A lot of the track was jointed rail, and kink-outs were common in hot weather. Likewise, pull-aparts were just as common in cold weather. Engine noise was so loud you couldn't talk with your Brakeman unless vou were in idle. There were no air conditioners, and the N&W insisted on running their engines long nose ahead, so at the end of your run your face was black with the engine exhaust.

"There was a caboose on every train in the yard transfer. There's not a ride in any carnival that is any more exhilarating or scary than when you hear the train go into emergency and you're on that caboose. No one had a clue what a computer was or how it would change the industry. Clerks were our computers. Now, everybody calls that the 'good old days."

Vice President Davis thanked his wife, Denise, and their children Cory, Beau, Danny, Jamie, and Addie for their unwavering support over the years. The couple celebrated their 41st wedding anniversary on October 1, 2018. He also thanked members of the BLET Advisory Board and all the General Chairmen and officers he has worked with over the years.

"I couldn't walk away without ac-

knowledging the many, many people that have played such a large part in my life for the last 48 years. I owe each of them so much for their friendship and support," Vice President Davis said. "These guys, and others like them, are what make the BLET the greatest union in the world. They have welcomed me into their Committees and homes, and I've gotten to know their wives and children. I am truly blessed to be able to call them Brothers and friends. These guys are the reason it's so hard to leave. The BLET's future because of them, and the many other young and dedicated officers, is bright."

National President Dennis R. Pierce recognized both Brothers during the convention.

"I think you'll agree with me that those two men are what put the 'Brother' in Brotherhood," he said. "Brother Gil, I do want to thank you for your years of service. The things that you have taught me along the way, I will never forget. I want to wish you and Denise a happy, long and healthy retirement. Thank you, Brother Cole. Thank you for your service. And I wish you and Denise a long and enjoyable retirement beginning in January."

- )) The first resolution cited the success of the **Coordinated Bargaining** Group (CBG) in the most

recent round of national contract negotiations, and it urges the BLET to play a leadership role in building a universal coalition of all rail labor unions that would potentially work together in the upcoming round of national bargaining.

- The second resolution emphasized the BLET's strong support of the Amtrak national passenger rail network, noting that the number of Amtrak passengers has continued to grow over the years in spite of attempts to kill the service. The resolution noted that: "the current Amtrak management is in the process of closing dozens of small-town train stations, downgrading service and amenities aboard many trains, while threatening to eliminate other trains completely." The delegates further resolved to condemn actions by Amtrak management, Congress, the President or the freight rail carriers to downgrade, erode or eliminate U.S. passenger rail train service.
- **III** BLET Vice President and National Legislative Representative John Tolman delivered an impassioned speech about the importance of elections and participating in the political process.





# 2018 Midterm Election Analysis

he Midterm elections are finally almost over. The voting is done but there are still a number of contested and/or uncalled races as this issue of the Journal goes to press. But what we know is the Democratic Party is now in control of one of the House of Representatives. The Republican Party is still in control of the Senate and the White House. This can and will provide for the sorely needed checks and balances for some of the crazy proposals that are brought forward and so hurtful to the Middle Class and the Labor Movement. We finally have friends in Congress who will provide a road block to stop the vicious attacks on labor that we witnessed in the past, such as attacks on Railroad Retirement, Social Security, Medicaid, Medicare, preexisting conditions, and the right for a majority of a workforce to freely choose union representation and for that union to be supported by all workers who enjoy the fruits of that representation.

With votes still being counted, an estimated 113 million Americans cast ballots in this first nationwide election of the Trump presidency, according to Associated Press data. Approximately 157.6 million people reported being registered to vote in the U.S. Voter turnout is generally around 40 percent during midterms.

- About 30 million more people participated in the 2018 midterms versus the 2014 midterms, representing the highest raw vote total for a non-presidential election in U.S. history.
- A staggering 36 million voters cast their ballots ahead of Election Day this year, setting the stage for much-higher-

than-usual turnout for a midterm.

- Voter participation approached presidential election-year levels in some states, including Wisconsin, Minnesota, Montana, Oregon and Colorado, where more than 60 percent of eligible voters cast ballots.
- Youth turnout, as defined by voters between 18 and 29, surged to a number not seen in a midterm election in a quarter century. Overall, 31 percent of eligible young people cast ballots.
- Women favored the Democratic candidate in their district by 19 percentage points (59% to 40%) while men voted for the Republican 51% to 47%.
- The most engaged voting bloc in the months leading up to the election, comprising 56% of the mid-term electorate, was over the age of 50.

#### THE GOVERNORS

When it comes to Governors' races, the Democrats started with 16 seats and are now looking, at least on Election Day, at 23 seats. Democratic strategists note that Democratic Governors now represent 52 percent of the nation's population. Republicans had to defend 26 of the 33 seats they held. The outcome of the GOPheld seat in Georgia remained uncertain at this writing.

Democratic governors were elected in Illinois, Kansas, Maine, Michigan, Nevada, New Mexico and Wisconsin. Also, Democratic governors won in every state they already held.

The seven governorships that the Democratic Party picked up include knocking off longtime anti-labor, mean spirited antagonist Scott Walker of Wisconsin. Voters also denied the Kansas Secretary of State, Kris Kobach, who was the Republican candidate for Governor in Kansas. Kobach is known as the motivating force behind dozens of proposals across the U.S. designed to suppress minority voting, immigrant

rights, and to promote white nationalist themes. And in Illinois, Bruce Rauner, who started the lawsuit that became the devastating *Janus* decision, also was ousted.

#### THE HOUSE

The real victory goes to the Democrats in the field who picked up 40 House seats! Currently their majority stands 241 to 194. The House of Representatives will now give Organized Labor and Middle Class families the checks and balances needed in Congress.

The most competitive races essentially broke along red and blue lines. Competitive races in purple or swing states tended to break slightly more toward Democrats than Republicans. Democrats had more of an impact in purplish states than in red states.

Democrats prevailed in other blue states held by Republicans, prevailing easily in Maine, Michigan and New Mexico, all open seats, while winning seats in the more purple states of Nevada and Wisconsin.

Democrats easily swept out most of the Republicans sitting in high-income suburban Clinton districts: Reps. Mike Coffman (CO-06), Peter Roskam (IL-06), Kevin Yoder (KS-03), Erik Paulsen (MN-03), Leonard Lance (NJ-07), Barbara Comstock (VA-10) and Mimi Walters (CA-45), all by comfortable margins.

In these seats, political advertising declaring the incumbent voted with President Trump "95 percent of the time" proved too much to overcome. But well-funded Democrats also broke through in outer, middle-class suburbs that Trump carried by single digits. Several were in places Barack Obama had never carried. However, Democrats didn't win a single Republican seat where Trump cracked 55 percent of the vote in 2016.

This was the first year in history Americans elected more than 100 women to the House, and it was almost entirely driven by Democrats. Of the 40 seats Democrats flipped, women were the Democratic nominees in 21 — accounting for over half of the Democrats' margin in the House.

#### THE SENATE

The Senate at the present time is still controlled by the Republicans with a 53

to 47 count. The Democrats have lost Claire McCaskill from Missouri, Heidi Heitkamp from North Dakota and Joe Donnelly from Indiana, but picked up Krysten Sinema from Arizona and Jacky Rosen from Nevada.

We also know that the 2020 race for the Democratic nomination for the Presidency has started. I know from my conversations with Democratic activists that many are uninspired by the cast of potential candidates in front of them now.

Rich Trumka, President of the AFL-CIO, said, "For months, street by street and person by person, we talked about the issues that matter most and the candidates who will put working families first. We have been mobilizing on a scale that I've never seen in my 50 years in the labor movement." I could say the same for our own Brotherhood. From BLET National President Dennis Pierce, to the BLET Advisory Board, to our State Legislative Board Chairman, to our General Chairman, and to our BLET Staff — we are engaged and on message. Thank you ALL BLET members for voting!

enjoy the fruits of their wellearned retirement.

Outside of the nomination and election of officers, the delegates also adopted several changes to the BLET Bylaws. We know the current antiunion environment that seems to prevail in Washington, D.C., and our delegates proactively took steps to help our Brotherhood grow and remain strong in the years to come. To that end, they adopted two particularly important resolutions. One allows for the creation of a Short Line Department, which will help the BLET expand its reach in organizing.

The second resolution allows the BLET to potentially grow the Organization by expanding our ability to represent a more diverse workforce by reaching out to workers of railroad companies not subject to the Railway Labor Act, such as so-called "light rail" systems. All Bylaws changes will become official once it has been confirmed that they do not conflict with the IBT Bylaws, and we expect to have approval in early 2019.

Our delegates also heard many motivational and uplifting speeches during the week. The speakers, highlighted within the pages of this *Journal*, reminded us that we are not alone in the ongoing War on Workers. Leaders

of other unions voiced their solidarity with the BLET. Delegates heard from members of the U.S. House of Representatives and the U.S. Senate. These elected officials let us know that we are not alone, and that that our issues are their issues. It was truly inspiring, and I know that I left the Convention feeling energized and motivated to continue the fight for all Middle Class Americans.

In closing, organizing a convention of this magnitude took countless hours of hard work, which can be measured in months, if not years. It was my goal, and that of the BLET Advisory Board, to put on the most well-organized convention

possible, so that our delegates could conduct the important work of our Brotherhood in the most professional and efficient manner possible. Our efforts culminated in Las Vegas from October 1-4, 2018, and I want to thank all those involved for their selfless efforts in making the BLET's Fourth National Convention a success. Now that the Convention is behind us, it's time to roll up our sleeves and get to work. We know that we have a great deal of hard work ahead of us and I look forward to working with our new Advisory Board and putting the plan that our delegates crafted into action. Truly, we will be United, Moving Forward!
