

Moving Forward

his edition of the Locomotive Engineers & Trainmen Iournal includes a convention wrap-up that gives all members a glimpse of the governing body of the Brotherhood of Locomotive Engineers and Trainmen at work. While in session, the delegates from our 500 Local Divisions decide what rules will govern our union and also set the course for the future of our Brotherhood and its membership. We should all be proud of how our delegates from all parts of the country performed those duties at our 2014 Convention. They were presented with a multitude of proposed changes to our Bylaws, many of which were submitted by my Office with the intention of bringing additional layers of accountability and transparency to our union and, in the end, our delegates made our union stronger by their collective actions.

Although our Convention was the culmination of many years of planning, it was also the beginning of many new activities, including the installation of a newly-elected Advisory Board. It was with great honor that I administered the IBT Oath of Office to each of the new Advisory Board members on January 1, 2015, which for the first time included our newly created and elected National Division Trustees. As with our Local Divisions. General Committees of Adjustment, and State Legislative

Boards, the Advisory Board of our BLET National Division now includes trustees, who will perform monthly audits of the finances of your National Division. Brother Walpert was elected as BLE's General Secretary-Treasurer in September of 2001, and became BLET's first National Secretary-Treasurer following our merger with IBT in 2004. We all owe Brother Bill a debt of gratitude for his tireless service to our Brotherhood, and I wish him well as he enjoys the fruits of his labor in retirement.

Our newest National Secretary-Treasurer, Stephen Bruno, also joins First Vice President and Alternate President E. Lee. Pruitt and me as Officers of your National Division Executive Committee. Just two months into that role, Brother Bruno is already leading an effort to reinforce our ongoing work to ensure that every member can be confident that the National Division manages BLET's assets in the most effective way possible. Our finances

are in good hands, and I look forward to serving with Brothers Pruitt and Bruno to make sure that our union is managed in a way that all members can be proud of.

The other newly elected addition to our National Division Advisory Board is Vice President James P. Louis. Brother Jim brings a multitude of experience to our Board, having served in many officer roles at the Local Division, State Legislative Board and General Committee of Adjustment levels. Brother Jim most recently served as General Chairman of the CSX/Conrail Shared Assets General Committee of Adjustment, and while that Committee is in good hands under the leadership of new General Chairman Pat Driscoll, that General Committee's loss was most definitely a gain for the National Division. In addition to his field assignments to our passenger/commuter General Committees, Brother Jim has been assigned to head our Education and Training Department, our Department of Internal Organizing, Mobilization and Strategic Planning, and to lead the National Division's new Regional Meeting program that will start in 2016.

Across the board, you can rest assured that the National Division Advisory Board officers elected in 2014 and sworn into office in 2015 will work tirelessly to protect the interests of the membership. BROTHERHOOD BOOKSHELF

BLET member co-authors another book on historic steam locomotive

The Clinchfield No. 1: Tennessee's Legendary Steam Engine By Mark A. Stevens and A.J. "Alf" Peoples Publisher: The History Press ISBN: 978.1.62619.596.7

t may seem like déjà vu, but BLET member A.J. "Alf" Peoples and journalist Mark A. Stevens have co-authored another book about the famous Clinchfield No. 1 steam locomotive.

Based on the success of their first book, *The One & Only: A Pictorial History of the Clinchfield No. 1*, the History Press asked them to do a follow-up. This time, instead of a pictorial history book,



"The Clinchfield No. 1, Tennessee's Legendary Steam Engine" is a definitive history book about 37,000 words and 160 pages.

Peoples is a member of BLET Division 781

(Erwin, Tenn.), whose railroad career spanned 45 years. He hired out as a car marshal on the Clinchfield Railroad in 1969 and retired as a CSX locomotive engineer in 2014. Stevens has served as a journalist, editor and publisher of both weekly and daily newspapers in Tennessee and Louisiana in a career spanning more than 25 years.

Released nationally on August 19, 2014, the book tells the everyday stories that made the locomotive a fabled symbol of survival and revival. Published by The History Press, the book features nearly 80 vintage photographs, many never before seen by the general public. Many of the stories, too, will be new to readers and railroad enthusiasts.

"The story of the Clinchfield No. 1, including how it was rebuilt in 1968 to lead excursion trains throughout the South, had been well documented over the years," Stevens said, "but Alf and I wanted to explore the stories behind the story. In particular, we wanted to tell the stories of the men who shaped the steam engine's life on the rails."

Utilizing materials available at East Tennessee State University's Archives

of Appalachia and through a series of interviews, Stevens and Peoples pieced together the captivating story of the real-world little engine that could. The book captures the spirit of railroaders who worked to turn an antique steam engine into the nation's oldest working locomotive. Those interviewed include 94-year-old George Hatcher, who served as fireman aboard the No. 1 for 11 years, and current U.S. senator and former Tennessee Gov. Lamar Alexander, who rode behind the No. 1 in 1972 and 1978 as part of a whistle-stop campaign launched by U.S. Sen. Howard Baker Jr.

Billboards support California high-speed rail plan

he Teamsters Rail Conference — in conjunction with other labor unions and special interest groups — launched a high-speed rail advocacy campaign in California throughout 2014. As part of the campaign, this pro-rail billboard appeared along Highway 99, which is the main artery connecting cities up and down the Central Valley of California. The Central Valley is where construction of the first 130 miles of the high-speed rail system will begin. More than 60,000 cars a day saw this billboard in the Bakersfield area. The campaign is part of a large-scale plan to bring about a renaissance of passenger rail through our high-speed rail advocacy efforts in California and around the nation, which will create tens of thousands of high paying union jobs.

Without a union, workers have few places to turn to when they need help. The BLET, the Teamsters and all unions act as a support network that will act on behalf of their members. In an age of low pay and increased job outsourcing, that can't be discounted.

The early pioneers of the BLET and our fellow Rail Labor unions — through their blood, sweat and tears fought to establish many of the benefits enjoyed by working Americans today (union and non-union alike). So you can tell the union doubters that if they like paid vacation, paid holidays, and health and retirement benefits, then they owe a debt of gratitude to the labor movement. And explain to them how it could all go away if we don't defend those rights.

When Americans head to the polls during election season, they get a chance to stand up for their values. Voting for pro-worker candidates won't just help union members — it will help all of us. Even that crazy uncle should be able to understand that message!

The Buy American procurement program has been on the books for more than 80 years. But it has become a target, thanks to the Trans-Pacific Partnership (TPP) deal being negotiated. The pact would remove the ability of the U.S. top prioritize com-

panies located in this country when making government purchases.

Under the trade agreement, the U.S. government would be required to grant all firms operating in any TPP country the same access as American companies to federal government procurement contracts over a certain value. The ban on preferential treatment for U.S. firms on obtaining government contracts

would result in the off-shoring of hundreds of millions in tax dollars now recycled into the U.S. economy.

While some might suggest that American companies will make up for any such losses through increased trading with other Pacific Rim nations, that is not likely. The TPP would allow Chinese government-owned firms in Vietnam to undercut American businesses in order to gain U.S.

government business. They can do that because the average minimum wage salary in Vietnam is 52 cents an hour.

America became the world power it is today by taking tough stands. Congress needs to assert U.S. independence now by standing firm against this TPP provision and allowing the Buy American program to flourish.

Following the convention, National President Dennis Pierce announced that Vice President Louis would serves as Department Head of the BLET's Education and Training Department as well as the BLET's Department of Internal Organizing, Mobilizing and Strategic Planning.

Bill Walpert bids farewell

Delivers moving retirement speech at BLET Third National Convention

LET National Secretary-Treasurer William C. Walpert delivered a heartfelt and emotional retirement speech on September 29 during the afternoon session of the BLET's Third National Convention.

"Today marks my final report to you, but I want you to know that when I make this last tie up, my thoughts will be of the Brotherhood and the Brotherhood and the Brotherhood," he said to a sustained standing ovation.

Walpert's railroad career spanned more than 41 years.

"I've always striven to stay true to the course set by our founders," Brother Walpert said. "In all my work for the Brotherhood, I have been mindful of the fact that I have been merely a custodian of the proud tradition of this great Organization. Bearing in mind the principles — paraphrasing the great American General, Douglas MacArthur — Duty, honor, brotherhood."

Brother Walpert has served as the BLET's National Secretary-Treasurer for 13 years, having been elected in 2001.

He is the union's longest serving Secretary-Treasurer since Brother H. F. Hempy, who took office in 1939, 75 years ago. As part of his retirement speech, he spoke about the financial good health and viability of our Brotherhood, as well as our growing membership, which has led to renewed strength.

During his tenure, the BLET launched ST Report, the union's revolutionary online dues and reporting system for Secretary-Treasurers. The BLET's Education and Training Department also grew to one of the best in the rail industry, especially with the launch of the BLET Training Center during the summer of 2014.

Brother Walpert also served as head of the Internal Organizing, Mobilizing and Strategic Planning Department for many years, leading the BLET's National Mobilization Team through many tough battles in the late 1990s and early 2000s. He also served as National Chairman of the BLET's Safety Task Force, representing the BLET in countless hearings before the National Transportation Safety Board over the years.

Training Department that will remain the nearest and dearest to his heart.



A major league retirement gift

n the months and weeks leading up to his retirement, former BLET National Secretary-Treasurer William C. Walpert received many gifts to mark the occasion, but perhaps none more special than a baseball autographed by former major league player and current manager Kirk Gibson.

Gibson, who spent most of his playing career with the Detroit Tigers (1979-1987), has served as manager of the Arizona Diamondbacks since 2010. Gibson is a two-time World Series champion (1984 and 1988), a National League Most Valuable Player (1988), American League Championship Series MVP (1984), and a winner of the Silver Slugger Award (1988). He may be best known for a home run he hit off Dennis Eckersley in Game 1 of the 1988 World Series during his time with the Los Angeles Dodgers.

Gibson was born in Pontiac, Mich., grew up in Waterford, Mich., attended Waterford Kettering High School and later Michigan State University. Thanks

to these Michigan roots, Gibson just so happens to be friends with BLET member Don K. Steele of BLET Division 920 in Pontiac, Mich.

Brother Steele approached Gibson about signing a ball for NST Walpert. Steele reports that Gibson does not normally give out his signature on baseballs, but made an exception for the BLET and NST Walpert. Steele described Gibson as a union man and a railroad supporter, and that it was his pleasure to sign the ball for NST Walpert for all his years of union service to the BLET.

The gift has special meaning for NST Walpert, who is a life long baseball fan and collector of baseball memorabilia.

BLET delegates back two-person train crews on final day of Third National Convention

elegates adopted a resolution pledging the BLET's unwavering support for two-person train crews on October 2, the final day of the union's Third National Convention.

"The single employee train crew issue is one of the most important questions facing rail labor, and specifically the BLET," the resolution reads. "Both SMART and the BLET are supporting federal and/or state legislation to stop the practice of single employee train crews."

The resolution highlights the plight of workers at the Wheeling & Lake Erie Railroad (W&LE), who have been fighting against single employee crews for years now, having gone on strike over the issue in 2013.

"It is vital that these brothers and sisters win this struggle and demonstrate to the W&LE — and the other rail carriers as well — that union labor will not accept train operations with a single employee," the resolution reads.

The delegates resolved to "pledge our unwavering solidarity and assistance to the members of Division 292 to win this fight." The resolution also calls upon all BLET members and all railroad workers to provide aid and support as necessary in the coming months and years in order to ensure victory.

After passage of the resolution, the BLET's Pennsylvania State Legislative Board pledged \$500 to the cause. Full text of the resolution is copied in the sidebar.

for treatment. The initial diagnosis was that Brother Perrien suffered from blood clots in his lungs, which made it difficult for him to breath.

Delegates to the convention passed the hat and collected more than \$4,000 in donations to help Brother Perrien and his family defray expenses related to his stay in the hospital. While expressing deepest gratitude for their generosity, Brother Perrien explained to the delegates that while the costs of his treatment were exorbitant, his out-of-pocket ex-

penses were minimal thanks to the quality health insurance plan negotiated by the BLET. He then humbly asked their permission to donate the money back to the National Division to establish a benevolent fund to help BLET members less fortunate than himself.

It was one of the finest examples of Brotherhood one could imagine, and Brother Perrien — and the BLET delegates — helped to establish a proud legacy of generosity that will continue to help those in need for years to come.

JARED MCNEW FUND

Brother McNew, 40, was serving as Local Chairman of Division 130 (Kansas City, Kan.) when he was involved in a horrific motorcycle accident in July of 2014. He sustained a number of critical, life altering injuries and has spent months in intensive care. His wife Julie and daughters Jennifer, 18, and Jasmine, 15, travel three hours on weekends to see Brother McNew at a rehabilitation facility.

FAMILY OF CHANCE J. GOBER

Brother Gober, 41, was a member of BLET Division 182 in North Little Rock, Ark. He was killed in the line of duty on August 27, 2014, when two Union Pacific trains collided head on near the town of Hoxie, Ark. He is survived by his wife Heather and sons Zach, 21, Jack, 12, and Clay, 10.

ERIC R. BUNCH MEMORIAL

Brother Bunch, 38, was serving as Local Chairman of Division 75 (Kansas City, Mo.), when he died unexpectedly of cardiac arrest on July 24, 2014. He is survived by his wife, Lari Sue, and sons Parker, 10, and Lincoln, 8.

JERRY D. CLOKE

Cloke, a retired member of BLET Division 523 (Chickasha, Okla.), needed help in paying medical costs and other bills associated with a kidney transplant.
